**NAME: Adam Smith**

Dr Adam Smith is a committed member and supporter of EIANZ since 2002, a fellow since 2006 and winner of the CENvP of the Year award in 2008. He has participated in several EIANZ leadership roles including Councilor, President, Vice President and Committee Member of the Far North Queensland Division. Adam has been a regular speaker at EIANZ events and annual conferences and has written several papers for the Australasian Journal of Environmental Management. Dr Smith is committed to conservation and sustainable management of the environment supported by the best available science and working in partnership with stakeholders. He has worked in multiple roles in research, consulting, management, not-for-profit and Boards including the Great Barrier Reef Marine Park Authority. He is currently Director of Reef Ecologic Pty Ltd which provides trusted expert advice and training on reef management. He has extensive regulatory, EIA, policy, project, partnership, grant, incident and communication experience in environmental issues and management.
