Proxies

Appendix A

Special resolution – Proposed amendment to the Rules of Association (CEnvP)

Notice is given that the following Special Resolution is to be put to the 2015 Annual General Meeting of the Environment Institute of Australia and New Zealand Inc.

BACKGROUND

The effect of the resolution is to amend the EIANZ Rules of Association to insert a new Division 4 in Part 6 to provide for the recognition of the Certified Environmental Practitioner Scheme as part of the structure of the Association. The resolution has been developed in conjunction with and has the support of the Certification Board and the in principle support of the Advisory Council.

The proposed amendment will provide a clear head of power for the establishment of the Scheme, and its operational and financial arrangements to be detailed in a By-law.

The amendment preserves the essential arm's length relationship between the Certification Board and the EIANZ Board.

PROPOSED SPECIAL RESOLUTION

In accordance with:

1. the Association's Rules; and
2. the *Associations Incorporation Reform Act 2012 (Vic)*

the Association hereby resolves:

To alter its Rules of Association pursuant to s.50 of the Act and Rule 86 of the Rules of Association, by inserting a new Part 6, Division 4 as follows:

PART 6

Division 4 – Certified Environmental Practitioner Scheme

75A. Certified Environmental Practitioner Scheme

- (1) The Association has established a scheme for the certification of the proficiency of environmental practitioners known as the Certified Environmental Practitioner Scheme.
- (2) The Certified Environmental Practitioner Scheme shall offer general certification of environmental practitioners, and specialist certification.
- (3) The Certified Environmental Practitioner Scheme shall be open to application by persons who may or may not be members of the Association.
- (4) Certified Environmental Practitioners shall be bound by the Association's Code of Ethics and Professional Conduct, and subject to the disciplinary and grievance procedures set out in Part 3, Division 3 and Division 4.

- (5) The Certified Environmental Practitioner Scheme shall be administered by a Certification Board, consisting of no less than five (5) and not more than seven (7) suitably qualified and experienced persons, appointed by the Board.
- (6) The Certification Board shall make decisions independently of the Board regarding certification of applicants; and subject to Rule 75A (9), the general administration of the scheme.
- (7) The financial operations of the Certified Environmental Practitioner Scheme shall be identified and operated separately from the general funds of the Association; reported not less frequently than quarterly to the Board, as part of the consolidated operations of the Association; and an annual financial statement for the Scheme prepared as part of the independently audited consolidated annual financial statement of the Association.
- (8) The Certification Board shall report regularly to the Board on the general performance of the Certified Environmental Practitioner Scheme; and the Certification Board and the Board shall consult regularly on matters which may affect the Scheme.
- (9) The Board shall prescribe in the By-laws, the minimum requirements for certification, the administrative, organisational and financial arrangements for the operation of the Certified Environmental Practitioner Scheme, and such other matters as are necessary for the good governance of the scheme.
