

# **NOMINATION FORM**

# Fellow of the Environment Institute of Australia and New Zealand Nominations close Monday 31 March YYYY

Fellowship is a form of recognition bestowed by the Institute on a current Full Member who has been a senior practitioner of influence in the environmental profession over a period of at least 10 years.

Calls for Fellowship nominations are made once a year but nominations can be made at any time. Nominees are appointed by invitation of the EIANZ President following review of nominations by the <u>Fellowship and Honorary Membership Review Committee</u> (FHMRC).

#### Nominees checklist:

- Nominees must be a current Full EIANZ Member for a continuous period of at least two years
- Nominees must be a <u>senior practitioner of influence</u> in the environmental profession over a period of at least ten years and can allow for career breaks. Nominations shall demonstrate evidence of senior roles and influence, which must include contribution to the Institute over part of that period
- Nominations must have a proposer and a seconder (The proposer must be a current EIANZ member and have known the nominee professionally for a period of at least 10 years. The seconder does not need to be an EIANZ member but must have known the nominee professionally for a period of at least 5 years)

Note: The nominee must not be a signatory on the nomination form, either as a nominor, seconder, verifier or referee.

- Nominations must include a resume or CV (a document or LinkedIn profile that lists at least 10 years of practice)
- Nominations must include between two and five professional referees and accompanying references
- Nominations must include a citation of no more than 150 words that can be used at a presentation or awards ceremony

# Senior practitioner of influence

Mary has directed the environmental practice at ABC for 12 years, is a regular guest lecturer at Latrobe University on the theory and practice of impact assessment, is a respected voice to industry and government, and has made a significant contribution to EIANZ (Vic), mentoring program and CEnvP panels.

#### Leading role in the environment profession

Please provide evidence (again with years) of the nominee's leadership in ways which have influenced environmental practice generally or benefitted the environment profession more broadly, including but not limited to positions of leadership within EIANZ (including CEnvP). It should be noted that 'leadership' implies personal responsibility for

the outcomes of a professional team or endeavour i.e., the nomination should make it clear that the nominee, in their position as 'x', was responsible for and played a leading role in 'y', which has benefitted the profession generally.

Under Mary's leadership, ABC has become one of the leading exponents of EIS in the resource sector in Victoria, and EIANZ (Vic) has become a respected voice to government agencies, effectively representing the opinions of the broader environment profession.

#### Professional standing and commitment to ethical practice

Please provide details to demonstrate this by awards, certification, published papers and invited conference presentations (also with years), and identify in referee statements and letters of support, attesting to the nominee's reputation, ethical practice and respect within industry, academia, environmental organisations, advisory and reference groups.

Mary is widely respected within the resource industry (she is on two industry reference / advisory committees) and by VCAT as a regular expert witness on environmental impact issues Senior positions occupied: See accompanying CV - Senior Principal ABC 2009-19, EIANZ Vic Div Policy C'tee Chair 2012-13, President 2014-16), Impact Assessment SIS Deputy Chair 2010-13, EPA Advisory C'tee on Impacts of Gas Extraction 2016-18

Mary Smith has demonstrated sustained leadership and influence within the environmental profession in Victoria through her senior role in a leading impact assessment consultancy practice, her contribution to EIANZ (Victorian Division) in a range of positions including President 2014-16, and her impact on industry and government through advocacy and representations on behalf of the profession. She is a skilled and experienced manager of large multidisciplinary EIS studies, and is widely recognised as an expert on the environmental impacts of resource extraction. As a practitioner whose opinions are sought and respected by regulatory agencies, and as an active contributor and mentor within EIANZ and the Impact Assessment SIS, Mary is a worthy recipient of an EIANZ Fellowship.
