Merit Awards 2020

Nominations close Wednesday 14 October

The EIANZ Merit Awards recognise members and practitioners who have made an outstanding contribution to the Institute and the environment profession. Calls for merit award nominations from EIANZ members for three of the five awards are made each year and generally coincide with the Institute's Annual Conference. Recipients are decided by the Board following review of nominations by the Merit Awards Committee.

Each year, five awards are presented. This nomination form is for the **first three awards**.

1.	Simon Molesworth Award	This is highest award bestowed by the Institute and recognises outstanding service to the Institute at an Institute level.
2.	Mary-Lou Morris Award	This award recognises a member of the Institute who has provided outstanding service to the Institute at a Divisional, Chapter, SIS or Committee level.
3.	Tor Hundloe Award	This award recognises outstanding contributions to the environment profession by a young professional.
4.	Eric Anderson Award	This award is for the best article published in the Australasian Journal of Environmental Management during the year and is decided and presented by the Journal's editors.
5.	CEnvP Award	This award recognises contribution to the program and is decided and presented by the Certified Environmental Practitioner Scheme Board.

Nominees checklist

- Nominees must be a current EIANZ member in any category (for the Simon Molesworth and Mary-Lou Morris Awards, this must for at least 2 years)
- Nominees for the Tor Hundloe Award must be aged 30 years or under at the closing date for nominations
- Nominees cannot be staff or contractors of the Institute
- Nominators must be a current FIAN7 member.
- Nominations must include:
 - > A statement up to 500 works explaining in detail how the nominee meets the relevant award criteria
 - > A statement of up 100 words explaining the reasons for the nomination that will be used as a citation when presenting the award
- Nominations can include a CV of up to five pages and/or a link to the nominee's LinkedIn page

Awards criteria

Award recipients are generally recognised for efforts across multiple years, and a broader contribution to the Institute will generally be considered more highly that a single activity.

Nominations need to:

- Clearly explain how the nominee meets the criteria for the relevant award
- Explain how the nominee is clearly outstanding that is, how they have gone above and beyond in their service to the Institute and the profession.

Simon Molesworth Award

The Simon Molesworth Award is the highest award bestowed by the Institute, recognising outstanding service to the Institute at an Institute level.

- To be eligible for this award, the nominee must have been a member of the Institute for at least two years
- The focus of this award is service to the Institute, so such activities are given greater weight than a nominee's professional experience and contributions
- Nominations should clearly explain the breadth and longevity of the nominee's contributions to the Institute, particularly efforts that are Institute-wide or across multiple Divisions and Chapter, and other groups including Special Interest Sections and committees

Mary-Lou Morris Award

The Mary-Lou Morris award recognises a member of the Institute who has provided outstanding service to the Institute at a Divisional, Chapter, Special Interest Sections, or committee level.

• To be eligible for this award, the nominee must have been a member of the Institute for at least two years

- The focus of this award is service to the Institute, so such activities are given greater weight than a nominee's professional experience and contributions
- Nominations should clearly articulate the breadth and longevity of the nominee's contributions to the one (or more) Divisions and Chapter, Special Interest Section, or committee

Tor Hundloe Award

The Tor Hundloe award recognises outstanding contributions to the environment profession by a young professional.

- To be eligible for this award, the nominee must be a member of the Institute and aged 30 years or under at 14 October 2020
- The focus of this award is on contributions to the environmental profession. That is, contributions to the Institute are considered important, but are given less weight than a nominee's professional activities.
