EIANZ SA Division Presidents Report 2023 AGM

I'd firstly like to thank the SA committee who have volunteered their valuable time and effort over the course of the year in keeping the SA Division functioning and organising events. Special thanks to Tegan for pulling the AGM together and performing admirably as the outgoing secretary.

I'd also like to say thanks to those members (and non-members) who continue to regularly support our events.

SA membership overview

SA's membership at the end of June 2023 was 100 (of which 5 are students), compared to 104 at 30 June last year. This makes up 5% of the overall EIANZ membership of 2109.

A report on SA membership trends over the past 5 years has been provided by the EIANZ Membership Coordinator (See Attachment 1). One of the more notable observations is that while full membership numbers are increasing, the number of associate and student members this past year has dropped.

SA also currently has 66 CEnvPs – mostly split across general or site contamination practitioners.

SA division event calendar overview

Over the past year we have had a number of networking events. We finished 2022 with an end of year celebration Thursday 1 December at Harrys Bar on Grenfell Street where we had an enjoyable evening socialising and networking over dinner and drinks.

The SA Committee came together in early January to have an events planning session at the Peak Iron offices — we tossed around a number of ideas for networking, professional development and site visit type events, and managed to smash some of Peaks glassware from memory. If anyone wants to be involved in planning or hosting a local event or webinar, then come and speak to one of the committee — we could really do with the help.

At the start of Mad-March we came together for an evening at Roxies Bar for more drinks and nibbles and then a couple of us ventured across to the Tandanya National Aboriginal Cultural Institute to experience a piece of fringe culture.

In June we held a lunch and learn event where Sally O'Neill of the TERN (Terrestrial Ecosystem Research Network) Ecosystem Surveillance program gave a presentation on their ecosystem monitoring program which has been in operation for over 10 years across 1000 long-term monitoring plots across Australia. Sally also talked about how the learnings are now being transformed into standardised protocols for national ecological monitoring programs.

Mentoring program

We have been unable to commence the 2023 mentoring program as of yet. We are considering running a condensed mentoring program over the latter part of the year with interested parties. Stay tuned for information coming out for this.

Other business – Derrick Sowa has stepped down from being the SA RAP representative, so that he can spend time on other EIANZ commitments. We are yet to fill this role. We also have Sally on the Policy and Standards Committee, so if there are any emerging local issues that the PSC can help with such as making submissions on matters out for public comment, have a chat to Sally.

Thanks for everyone who helped out with these activities and roles over the course of the year. Its not easy fitting this in amongst your hectic day to day working lives.



Treasurer's Annual Report

2022-2023 TREASURER'S REPORT

<u>Treasurer Summary – SA Division - financial year ended 30 June 2023</u>

Total income for the 2022/23 financial year was \$5,613 and total expenses were \$1,303 resulting in a net surplus of \$4,309. This result was boosted no doubt by the share of the surplus from last year's SIS Impact Assessment Symposium granted to the division.

The Balance Sheet at the end of 22/23 shows an equity position (net assets) of \$22,743.

At 30 June 2023, the division had 104 active members consistent with last year, comprising 83 Full members, 4 Fellow members, 2 Honorary member, 9 Associate members and 6 student members.

Events for 2022/23 are summarised below:
