Reconciliation Australia

Reconciliation Australia is a not-for-profit organisation that aims to facilitate reconciliation by developing relationships, respect and trust between Australian communities and Aboriginal and Torres Strait Islander peoples. They focus on five critical dimensions of reconciliation: race relations, equality and equity, institutional integrity, unity, and historical acceptance. Businesses and organisations can register to create a Reconciliation Action Plan (RAP) which gives them a framework to work towards reconciliation. EIANZ is in the process of finalising its first RAP which will provide the Institute with a roadmap to begin its reconciliation journey.

Culture Matters

Culture Matters is an initiative which considers the underlying principles that apply in relation to diversity based on any dimension of culture: age, gender, nationality, sexual orientation, religion, class, ethnicity. They offer a free introductory course designed to promote awareness of the complexity of culture and to explore strategies which support working in more inclusive ways. While this course focuses on all aspects of cultural awareness - it frequently discusses Māori examples, particular relating to the Treaty of Waitangi.

Barry J Hunter is a descendant from the Djabugay speaking people of Cairns hinterland. Barry has over 30 years' experience in Aboriginal affairs particularly in areas of land, natural and cultural resource management. He is the Chairperson for the Aboriginal Carbon Foundation, a Board member of Terrain NRM and the Lead Author, Indigenous Lands, for the Australian State of the Environment Report 2021

Billy van Uitregt has Ngaa Rauru, Whanganui, Tūhoe, and Nederlander tribal and cultural affiliations. He lectures in Environment and Earth Sciences at Victoria University, Wellington. In Australia he worked with the Anindilyakwa Land and Sea Rangers in Northern Territory and then with First Nations communities in the South Australian Murray-Darling Basin on water policy. He is currently researching indigenous worldviews and knowledge, particularly around environmental conservation.
